

## PRIVACY POLICY

Information pursuant to the personal data protection code. (Legislative Decree n. 196 of 30 June 2003)

The Legislative Decree n. 196 of 30 June 2003 has the purpose of guaranteeing that the processing of your personal data is carried out in compliance with the rights, fundamental freedoms and dignity of persons, with particular reference to privacy and personal identity.

We inform you, pursuant to art. 13 of the Code, that the personal data supplied by you or otherwise acquired in the context of the activity we carry out, may be processed, for the purposes connected to the exercise of our activity, as better specified below. By processing of personal data we mean their collection, registration, organization, conservation, processing, modification, selection, extraction, comparison, use, dissemination, cancellation, distribution, interconnection and anything else that is useful for the provision of the services provided by our company, including the combination of two or more of these operations.

Park And Fly Srl performs data processing operations that you provide when registering for the service Park And Fly Srl , which can be traced back to the sites of the Park And Fly Srl network .

The processing of your data for the purposes specified below will take place mainly with automated and IT methods, always in compliance with the rules of confidentiality and security established by law, and with procedures suitable for protecting them.

The personal data controller is Park And Fly Srl , with registered office in Fiumicino, Via Portuense 2365, in the person of its legal representative (hereinafter: "Park And Fly").

The provision of personal data on your part is absolutely optional; however, any refusal to include them on the registration page makes it impossible for you to receive our services, as also promoted on the [www.parkandfly.it](http://www.parkandfly.it) site, as well as your registration on the same website and loyalty programme.

Your personal data is processed as part of Park And Fly 's normal activity for the following purposes: - purposes strictly connected and instrumental to the management of customer relations (e.g.: execution of operations on the basis of the obligations deriving from the contract concluded with customers, etc.);

- purposes related to the obligations established by laws, regulations and community legislation, as well as by provisions issued by authorities legitimated by the law or by supervisory and control bodies;

- purposes functional to the activity of Park And Fly . The following activities fall into this category: a) detection of the degree of customer satisfaction with the quality of the services rendered and with the operations carried out by Park And Fly performed directly or through the work of specialized companies through personal or telephone interviews, questionnaires, etc. .;

b) promotion and sale of Park And Fly products and services or of third-party companies, carried out through letters, telephone, advertising material, automated communication systems, etc.;

c) market surveys. The data, or some of them, for the purposes expressed above, may be communicated to: companies belonging to the same corporate group to which Park And Fly

belongs ; external subjects who perform functions connected and instrumental to the operation of the services offered by Park And Fly , such as, purely by way of example, the management of the IT system, assistance and consultancy in accounting, administrative, legal, tax, commercial and financial matters ; subjects whose right to access the data is recognized by provisions of the law or by orders of the authorities.

By submitting the form, you fully accept this information pursuant to art. 10 of Law 675/96. The personal data collected by sending this form are processed exclusively by Park And Fly to respond to your requests. Even in the presence of your consent, we inform you that, pursuant to and by effect of Art. 9 paragraph 1 lett. e) and c) of Law no. 675 of 1996, such data will in any case be canceled and/or destroyed starting from 12 months from the date of sending of this message. You can ask, at any time, what your personal data are stored and how they are used. You can also exercise the right to correct, update, cancel and oppose their treatment (according to the provisions of Article 13 of Law No. 675/1996).
